

“What About Abortion in the Case of Rape or Incest?”

Dear Sue,

I just read your article on [abortion](#) as a source to prepare a message on abortion. Thank you for a well written, well documented work. Many of the sermon reviews I have done so far lack documentation for the claims being made in the sermon. I am curious to know more regarding your point when you touched on the issue of abortion because of rape or incest. What you would say to women in those situations, and do you leave a little more room for personal decision there?

Thank you for your kind words about my article.

Since I am a woman, I've definitely thought about the possibility of pregnancy resulting from rape: what would I do if it happened to me? As traumatic and life-altering as rape is, I would still need to pass it through my Christian worldview filter, and I come to these conclusions (which also apply to incest):

1. God is still in control, even when He allows unspeakable evil into our lives.
2. Because He is good, that means He has a purpose and a plan to redeem even unspeakable evil, which means we can trust Him.
3. Pregnancy resulting from rape or incest brings an innocent child into existence, who has a right to life because God has made him or her in His image. He loves them and He has a plan for their lives, or they would never have been conceived.
4. Aborting a baby conceived by rape or incest doesn't make the pain go away, and it doesn't make the problem go away.
5. It makes it worse because the lingering guilt of abortion is horrific. A woman will often start to think of her life as divided into BA/AA (before the abortion/after the abortion).

6. In addition to the trauma of being raped or incested, a woman is then further burdened with post-abortion syndrome. (See my article "[The Dark Underside of Abortion.](#)")

I understand that from a human standpoint, giving "more room for personal decision" to abort in the case of rape or incest makes sense. But from an eternal, biblical perspective, it still violates God's command not to murder, and it still incurs the consequences of one's own sinful choice. When a woman is victimized by rape or incest, she is not responsible for what was done to her, but she is responsible for her response to being sinned against. Sinning against her unborn baby and against herself is not justified, even though we certainly understand why she would do it. The need for compassion is excruciating. Which is why, if I were were talking to someone pregnant as the result of rape or incest, I would gently and lovingly give her the bigger picture of what is at stake.

Thank you so much for asking for clarification on my position on this important question. I am grateful for the chance to explain what I have hammered out concerning this very difficult issue.

The Effect of Origins on Society

Why Is the Subject of Origins Important?

Every worldview addresses the question, “Where did we come from?” The Christian worldview says that we are a special part of creation made in the image of God. A materialistic worldview says that we are the product of natural selection and random mutations acting on organisms. The Christian view of origins is called Creation; the materialistic view of origins is called Darwinism. The Christian worldview is based on faith in the creative work of God of the Bible. The materialistic worldview is based on faith in the creative power of natural selection acting on mutations.

There are evidences for and against these worldviews from scientific research being conducted in the areas of intelligent design, evolutionary biology, genetics, mathematics, astronomy, and many other fields. However, people will often confuse the worldview with the scientific evidence. Worldviews are a way of explaining the evidence. For example, we see that during a drought birds with longer beaks are selected over birds with shorter beaks. This is an observation. Saying that this is evidence for natural selection’s creative ability to make totally new types of creatures is an extrapolation based on a worldview. Just as there is a right and a wrong interpretation for observations, there are right and wrong worldviews. And one way to test for a worldview is whether or not it is livable.

So does your view of origins affect other areas of life than just science? Yes, these two views of origins have a profound effect on how we value people and how we view personhood and personal responsibility. Using John West’s book *Darwin Day in America* as a resource, we will look at how the materialistic worldview has trickled down into areas of society that affect us every day.

West argues in his book that the logical end materialistic worldview leaves nothing for an ethical standard other than to

survive. The materialistic worldview says that non-living chemicals came together to make genetic material which then made an organism and that organism evolved until we got human beings. This view claims that man is made from chemicals and is no more valuable than any other animal. The logical end to this perspective is that everything a man does is a result of his genes and his environment. He therefore has no choices or free will of his own. His actions are the result of natural selection acting on him. This has important consequences for how we deal with crime, personhood, the embryo, the infirmed, and education.

West says, "Darwin helped spark an intellectual revolution that sought to apply materialism to nearly every area of human endeavor. This new, thoroughly 'scientific' materialism affected the entire span of culture, from economics and politics to education and the arts".^[1] Darwin published *Origin of Species* one hundred fifty years ago, but it is in the mid-twentieth century that we begin to see how his theory has trickled down into society.

Crime and Responsibility

How does a materialistic worldview affect society? For one thing, a Darwinian view of man has changed our criminal justice system.

How are the courts and science related? In our culture, the scientists are the holders of truth and the courts are the arbiters of law. And while the idea that law coincides with truth is good and even biblical, the idea that scientists, and only scientists, are the ones who dictate truth is a dangerous position. If the pervading worldview in science is materialism, then a materialistic view of man is reflected in the courts.

According to a materialistic worldview, man is the product of

his genes and his environment with no real ability to act differently than what his genes and environment would have him do. If this is the case, then how can he be held responsible for his crimes? Why not just blame bad genes or a bad home life? Often this is what is argued in the courts.

West describes the crux of the problem. In order to provide protection and have an orderly society, the criminal justice system needs to punish wrong behavior. But from a materialistic worldview, there is no moral foundation for individual responsibility. A materialist perspective does not blame the individual but their genes or the way that they were raised (their environment). West outlines a history of criminals getting off in the name of very loose definitions of insanity, and other criminals undergoing treatment instead of punishment.^{2} And the treatment, at times, amounts to something closer to coercion or torture.^{3} Whether we are talking about being overly lenient by giving criminals excuses or coercing them to treatment, both diminish the value and dignity of the individual as a person.

The Christian view of man is that, although differences in our genetics or our environment may mean that we have different struggles or temptations than others, we are made in God's image. Therefore, just as God treats us with dignity by exacting punishment for our actions, so, too, do we treat people with inherent dignity by exacting punishment and allowing for atonement. The Darwinian view says that we are not responsible because we are a product of our genes, but it also says that we are not redeemable because we will remain flawed.

Our entire criminal justice system is based on the idea that man can be held accountable for his crimes, that he has a choice in what he does. Furthermore, it is based on the inherent dignity that every individual has, so that a wrong done to one individual must result in the wrong-doer being punished. This maintains equal dignity and value in both

individuals.{4} However, this system crumbles under a materialistic worldview.

So man is a product of his genes and his environment, a view which, taken to its logical end, has conflicting and dangerous results for exacting justice in society. Now we turn to how this view of man affects how we treat others that are different from us and how we define “normal.”

Personhood

At the beginning of the twentieth century, during the rise of the scientific revolution, the idea of atonement for a guilty crime changed to an idea of fixing a broken machine. Criminals were treated as if they were machines with broken parts, instead of individuals with value and free will, because scientists had supposedly found a materialistic cause for crime. Something in their genetic code went wrong, so many were subjected to some kind of institutionalization or treatment. As John West points out in *Darwin Day in America*, the idea is if science can explain the problem, then science can fix it.{5} One way that scientists attempted to fix this problem was to try to breed out the bad traits. Scientists in the '30s, '40s and '50s reasoned that bad behavior, stupidity, and emotional instability were passed down from parent to child just like physical traits, and the only way to cleanse our society of these ailments was to sterilize those who carry these traits.

It began with criminals being sterilized; then it turned to those who were mentally handicapped; then those who were deemed less intelligent, poor, or unproductive in society were sterilized. In hindsight it is easy to see how this slippery slope happened. One group changes the standards by which we value other groups. No longer is the foundation in the Judeo-Christian concept that all individuals have inherent value, but in the Darwinian concept that some are less valuable than

others and deemed less worthy of life than the more “fit” in society. This was the breeding ground for what would become the eugenics movement. [Editor’s note: Eugenics is the idea that the human race can be improved by careful selection of those who mate and produce offspring. The word comes from the Greek word *eugenes*, “well-born, of good stock,” from *eu-* “good” + *genos* “birth.”]

We saw the logical end of the eugenics movement in Nazi Germany. Darwinism was not necessarily the cause for Nazi Germany, but eugenics was justified with a Darwinian view of man. This is an important picture of how one can promote one’s worldview (and one’s prejudices) in the name of science. Darwinism allows for race discrimination and even genocide. As West points out, “Historically speaking, the eugenics movement is important because it was one of the first—and most powerful—efforts to use science to expand the power of the state over social matters. Eugenists claimed that their superior scientific knowledge trumped the beliefs of nonscientists, and so they should be allowed to design a truly scientific welfare policy.”[\[6\]](#)

Today this attitude is still seen when doctors, lawyers, and family members evaluate individuals based on their physical abilities and their cost to society. Oftentimes individuals are assessed based on their perceived “quality of life.” Unfortunately, this usually reflects what the doctor, lawyer, or family member would hate to have happen to themselves than the actual desires of the individual in question. Judging others unworthy of life based on physical features or capabilities ignores the inherent value and dignity God has given man as being made in His image.

The Beginning and End of Life

We have looked at how a society that promotes a materialistic worldview results in a degraded view of personhood. This

degraded view includes basing a person's value on how well they physically function and how much they cost society. However, from a Christian view, humans were created with a purpose and in the image of God. They have inherent value beyond their physical bodies.

How does a Darwinian view of man's origin affect the way we look at the most vulnerable in society—the embryo and the aged or infirmed?

West traces a historical record of the legalization of abortion and demonstrates why we have the debate about embryonic stem cell research today.[\[7\]](#) Darwinism is not the cause of the legalization of abortion and destruction of embryos, but it provided an ideology that allowed people to justify it. It began with a scientist named Haeckel who influenced Darwin. Haeckel discussed how all embryos go through stages of development and how the earliest stages look very similar to each other. In his famous drawings, he shows how a human embryo goes from a small fish-like creature that looks similar to other animal embryos, to a human-looking embryo. He said that the fetus goes through a mini version of evolutionary development.[\[8\]](#)

What conclusions were drawn from this? If the fetus is no more than a fish, then it is as ethical to discard it as it would be to discard a fish. The only problem with this idea is that it is now well-documented that Haeckel's drawings were faked, and the similarities were more contrived than real. Despite this finding, people still latched on to the concept and refused to accept that the fetus does not go through evolutionary stages. It is from this concept that many justify early stage abortion and embryonic stem cell research; the clump of cells or the mass does not look human.[\[9\]](#) This is an example of basing a person's value on their physical appearance and function.

Today we not only see this idea played out in the unborn, but

also in the elderly and the infirmed. Many family members and doctors elect to end someone's life because they have deemed them less valuable. Again, the basis of this is on how well they physically function. One group is putting value on another group.

Both of these examples demonstrate how our culture has bought into a materialistic worldview which devalues the person that does not have certain physical characteristics. As Christians we value human life and believe that the embryo, the aged, and the infirmed have inherent dignity despite how they might function or appear.

Education

We have been looking at how a Darwinian view of man led to a slow and steady dehumanization of man. Our view of origins affects other areas of life as well. In this section, we will address how a Darwinian view of man has influenced how we educate our children. A Darwinian view says that there is no absolute authority; there is merely survival of the fittest. In academics that means teaching based on what works, not on what is right.

One of the biggest influences on our educational system, both in public and private schools, has been John Dewey. As Nancy Pearcey points out in her book *Total Truth*, Dewey thought education should be like biological evolution where students construct their own answers based on what works best. Pearcey calls this "a kind of mental adaptation to the environment."[\[10\]](#) It is easy to see how this leads to moral relativism. Students are not taught character or values. Instead, they learn that an idea or a concept is deemed valuable if it works, not if it is right. Teachers are taught in certification classes to guide students along and help them to come up with their own moral code. Teachers are not allowed to punish students for wrongdoing, because they have no moral

basis to do so, but are still expected to have an orderly classroom. In some cases teachers are not permitted to give a failing grade to a student who is genuinely failing. Also they are not permitted to give A's to good students for fear that they may not continue putting forth effort. Students are stripped of the concept of an objective standard or absolute morals, and by the time they are high school seniors, they are more educated in how to play the system than in reading, writing, or arithmetic. This is the very fruit of Dewey's pragmatism, and it continues through the university level. When students are stripped of any set of beliefs and a moral foundation, they are left empty and ready to be filled with the pervading worldview of academia. What we end up with is a fully indoctrinated student with a materialistic worldview.[{11}](#)

Contemporary materialism's view of origins, known as Darwinism, has profound effects on our society. As Christians we need to be a light unto the world by showing that human beings are more than their genes and environment, that they have inherent value, and that there are moral foundations beyond survival of the fittest.

However, please consider the possibility that people who bomb clinics and murder abortionists and harass people are acting on their own choice instead of taking their orders from what God has said in His word. The Old Testament property laws show that God wants us to respect other people's property, and bombing clinics is a violation of that. Murdering doctors is a direct violation of the commandment "Thou shalt not murder." Harrassing people is a violation of God's command to love our neighbor as we love ourselves.

So let's say your beautiful wholesome daughter was raped by a psychotic crazed madman and he got her pregnant. You would welcome that half-crazed child into your life? Or going off of anti-abortion tactics, obviously you would just kill her and say it was in the book of Hypocrite, or wait. . . you would put the baby up for adoption and not tell the parents that this is a child of a rape.

Let's go one step further. I'm a woman; during my childbearing years I lived with the possibility that it could have been me getting impregnated through a rape. I did think about what we would do. Because there's a big difference between pre-deciding a response to a hypothetical situation and actually living it, we had two choices: welcome the baby into our family as a continual reminder of what grace (undeserved

blessing and favor) looks like, or giving the baby up for adoption. There is a growing number of infertile couples who would give anything to bring such a life into their home, regardless of how he came to be. The baby would be an innocent party who had nothing to do with his or her conception. (And even if the father were a "psychotic crazed madman," that doesn't make his offspring crazy.)

You see the problem here don't you? But of course it's not a problem in your eyes until it hits home isn't it.

It would be a very *big* problem. Our response is that we have an even bigger God.

Oh I guess you anti-abortion activists will continue to bomb buildings, murder people and harass people in the name of god. Wow. . . you know what. . . that is rather hypocritical isn't it.

Yes, it is hypocritical to do things in the name of God who forbids us to do those things. I'm curious, though, why you wrote to Probe Ministries, since none of us are anti-abortion "activists." Not a one of us has ever bombed a building or murdered doctors or harassed people. I'm also curious. . . are you able to consider the possibility that people who cross God's lines, no matter how well-intentioned they are, are a tiny minority of those who are passionate about this issue?

We think it's interesting that in today's culture, it's not okay to blame all Muslims for the actions of extremist Muslim terrorists (and of course it's not). . . but it's acceptable to blame all Christians for the actions of a handful of extremists? Isn't that what you're doing here?

Murder is OK, it must say so in some part of the bible that I missed too. . . and bombing. . . does it say anywhere there "And the lord, place a bomb in the building to blow it up"? Man, I musta skipped over that section.

You're right. Murder and bombing other people's buildings are not instructed in the Bible. In fact, the Bible tells us to do the opposite of those things. The people choosing to resort to their own methods in hopes of achieving their goals are not basing their choices on biblical values or principles. They do what they do *in spite of* what the Bible says, not because of it.

"How Does the Bible Show Abortion is Murder?"

In my "Introduction to Ethics" class, the topic for the night was abortion. As the discussion progressed, people all around me were saying that an abortion is good to do under any situation (rape, too young, the woman's choice) and I argued

my point on that abortion is murder. I stated that the Bible had claimed to that statement also. The teacher then told me that I have to prove to him and the class that the Bible says abortion is murder. Can you help me with verses, or anything I could possibly use to make my point valid?

Glad you asked!

The perspective that abortion is murder depends on two points: 1) The Bible condemns murder (taking the life of another human being), and 2) The unborn baby is a person—a human being.

Point #1: What is murder?

Exodus 20:13, usually translated “Thou shalt not kill,” one of the Ten Commandments, actually means “Thou shalt not murder.” (There is a difference. Taking the life of another person in war, for example, is not the same thing as murder.)

Point #2: The humanity of the unborn

1. Both Hebrew and Greek (the languages of the Bible) do not make a distinction between pre-born and born babies. Whether they live inside or outside the womb is not important as to their value or personhood.

2. For You created my inmost being; You knit me together in my mother's womb. I praise You because I am fearfully and wonderfully made; Your works are wonderful, I know that full well. My frame was not hidden from You when I was made in the secret place. When I was woven together in the depths of the earth, Your eyes saw my unformed body. All the days ordained for me were written in Your book before one of them came to be. (Ps. 139:13-16)

This portion of scripture is written about the unborn baby.

*3. The Lord called me from the womb;
from the body of my mother He named me. (Is. 49:1)*

The prophet Isaiah says he received God's calling and naming while still in the womb.

4. Surely I was sinful at birth, sinful from the time my mother conceived me. (Psalm 51:5)

The psalmist states that he was a spiritual being from the point of conception. This isn't saying that he sinned while in the womb, but that he recognizes that from the earliest part of life, he was a sinner.

5. Now the word of the Lord came to me saying, "Before I formed you in the womb I knew you, and before you were born I consecrated you; I have appointed you a prophet to the nations." (Jer. 1:4-5)

Jeremiah declares that God knew him, consecrated him (set him apart), and appointed him a prophet before he was even conceived! From God's perspective, Jeremiah's humanity began even before conception.

6. At that time Mary got ready and hurried to a town in the hill country of Judea, where she entered Zechariah's home and greeted Elizabeth. When Elizabeth heard Mary's greeting, the baby leaped in her womb, and Elizabeth was filled with the Holy Spirit. In a loud voice she exclaimed: "Blessed are you among women, and blessed is the child you will bear! But why am I so favored, that the mother of my Lord should come to me? As soon as the sound of your greeting reached my ears, the baby in my womb leaped for joy. (Luke 1:39-44)

The unborn John the Baptist had a physical reaction to the presence of Mary and ESPECIALLY her unborn Child. At this point, Jesus was probably only a week- or two-old embryo. (Scripture tells us that as soon as the angel Gabriel spoke

to Mary about God's plan for the Holy Spirit to overshadow her and conceive the Messiah in her and she consented, she hurried to see Elizabeth, who lived about 70 or so miles from Nazareth.)

I believe that these verses indicate that abortion is murder, but all you can do is offer the light they provide. Some people who don't want to believe that abortion is murder or that an unborn baby is anything more than a "potential human being" can and will refuse to accept it. (Remember what the Word says in Jeremiah 17:9—"The heart is deceitful above all things, and desperately wicked: who can know it?") Your job is to pray for God to open the eyes of the hearts of the others in your class, humbly offer the truth, and leave the results to God.

India's Missing Girls and the Right to Choose

Rusty Wright and Meg Korpi reveal that female infanticide and feticide in India's patriarchal culture stir passions for equality and fairness but raise troubling questions. Does

favoring a woman's right to choose logically imply that one supports her right to terminate a fetus simply because it is female?

Last summer, a farmer in southern India discovered a tiny human hand poking from the ground. A two-day-old baby girl had been buried alive. The reason? Much of Indian culture favors males over females, sometimes brutally so. The girl's grandfather confessed to attempting murder because his family already had too many females; keeping this one would be too costly.

This wasn't an isolated incident on the subcontinent according to award-winning filmmaker Ashok Prasad. Prasad spoke recently at Stanford University at the U.S. premiere of his BBC documentary "India's Missing Girls." Anti-female bias affects Indians rich and poor. Males can perpetuate the family name, bring wealth, and care for elderly parents. A female's family typically must pay a huge dowry when she weds, often depleting family resources. A popular Hindi aphorism: "Having a girl is to plant a seed in someone else's garden."[\[1\]](#)

Female Infanticide and Feticide

Against odds, this baby survived, but social and financial pressures bring alarming rates of female infanticide and feticide (termination of a fetus). UN figures estimate 750,000 Indian girls are aborted every year.[\[2\]](#) Demographic studies reveal dramatically growing gender disparity since the 1980's[\[3\]](#); in some regions only 80 baby girls survive for every 100 boys.[\[4\]](#) Many men cannot find wives.

Financial repercussions are typically cited as the reason for discarding daughters, but the decision is often an economic choice rather than necessity. Greater gender disparity occurs in wealthier states.[\[5\]](#) These families can better afford the sex determination tests and sex-selective abortions that, according to a report published by the UN Population Fund, are

the main contributors to the decreasing proportion of female children.[{6}](#)

Adding to the offensiveness of sex-selective abortion: the fetus must be well-formed (15-18 weeks) before the sex can be detected using ultrasound-the common sex-determination technology. “India’s Missing Girls” includes brief, grisly footage of terminated female fetuses being lifted from a well belonging to a clinic that performed sex-selective abortions. After the discovery, outraged women’s groups protested in the streets; several such clinics were closed down.

The heartening side of the documentary is Sandhya Reddy, who runs a children’s home, cares for abandoned kids, and tries to persuade mothers to keep their daughters or girl fetuses. This angel of mercy brings love, care and opportunity to society’s young rejects.

“India’s Missing Girl’s” poignantly depicts where devaluing women can lead. The Stanford screening’s sponsors included feminist and women’s organizations, but feminists and nonfeminists, liberals and conservatives alike will be moved. Troubling Questions

To Western sensibilities, killing babies and terminating fetuses solely because of gender is abhorrent. Yet no Hitler masterminds this mass extermination of females. It results from hundreds of thousands of personal decisions.

As the U.S. recognizes 35 years of *Roe v. Wade*, feticide’s increasing contribution to India’s missing girls raises a disturbing dilemma: Doesn’t favoring a woman’s right to free reproductive choice logically require supporting her right to terminate a fetus simply because it is female?

Important worldview questions emerge. Opposing female feticide

seems to ascribe some sort of value to the female fetus. Is this value inherent because the fetus is female? If so, wouldn't equality require that we ascribe similar value to the male fetus because it is male?

Or is the fetus's value utilitarian, e.g., to ensure female influence in society or sufficient brides? Or is it merely economic-negative for Indian females, positive for males?

An enduring view of the fetus's value appears in Psalm 139. King David's worldview recognizes awe-inspiring biological intricacy fashioned by the Divine: You made all the delicate, inner parts of my body and knit me together in my mother's womb. Thank you for making me so wonderfully complex!{8}

Inherently valuable? Socially useful? Economically consequential? Wonderfully complex? The troubling quandary still haunts: Can opposing female feticide be reconciled with supporting reproductive choice? The question demands a logically consistent answer from every thinking person.

“Will God Punish Me Forever for My Mistakes?”

I am so depressed right now because I feel all the mistakes in my past mistakes are so many that I won't have a good future.

I'm 29 years old and I had 2 abortions before I was 20. Two years ago I slept with my boyfriend even though I was already a Christian; we went our separate ways because of this. (He's also a Christian.) I have been single ever since and I have been told that I am being punished for all my sins. Does this mean because of what happened in my past I will never find peace, joy or fulfillment? Does this mean God will never trust me with a relationship again? Will I have to pay for the rest of my life?

Will He refuse to forgive me since I made the mistakes when I was already a Christian? I have been so tormented by all this and I am in constant pain—my heart aches. I really don't know

what to do, I have prayed and asked for forgiveness, don't know what else to do. All I feel is guilt, guilt, guilt.

Oh, you precious girl! I have such wonderful news for you!! Your flesh and Satan have been doing a number on you, pouring guilt and self-condemnation onto you all this time . . .when God has been standing there, extending grace and mercy and complete forgiveness to you, wanting you to receive it, but you haven't been able to see it.

How do I know this?

Because of "the Christian's bar of soap," 1 John 1:9—"If we confess our sins [and you have, over and over and over, right?], He is faithful and just to forgive us our sins and to cleanse us of all unrighteousness." Note that God does two things when we confess: 1) He forgives us, which means He sends them away forever, and 2) He cleanses us of ALL unrighteousness, making our souls clean and pure as snow. What's missing for you is the decision to consciously RECEIVE His forgiveness and cleansing.

Are you being punished for your sins? Well, consider this: there is a difference between punishment, which includes wrath being poured out on us, and the consequences of our choices, which is loving discipline. Romans 8:1 says that there is NO condemnation for those who are in Christ Jesus, because the Lord Jesus took all of the Father's condemnation on Himself on the cross. So God is not punishing you. Are you experiencing consequences for your sinful choices? Maybe in the beginning. But from what you describe to me, with peace, joy, and fulfillment eluding you, it sounds like you have your cup upside down, which is preventing you from receiving any new blessings from God because of the mistaken belief that you are still under condemnation.

No, beloved sister, you will not have to pay for the rest of your life. What God wants is repentance, and you have already

done that. Scripture says that godly sorrow leads to repentance (2 Cor. 7:10), but there is a worldly sorrow, fed by our own flesh or by demonic forces in temptation, that leads to death. And that's where you've been living, hasn't it? Camped out in a living death?

I would love to lead you in a prayer to receive God's forgiveness and cleansing. May I also suggest that you do something physical to make it more real: lift up your arms, palms up, like a small child ready to be picked up by her daddy: *Dear Father, I want to turn my cup right-side up and receive all the forgiveness and cleansing You have for me. I make a choice today to open my heart to You and let You love me, let You forgive me, let You cleanse me from all unrighteousness. Thank You for exchanging my sin for Jesus' righteousness. Thank You that Your word is true, that because I have confessed my sins, You are faithful and just to forgive me of my sins and cleanse me of all unrighteousness. I receive it in Jesus' name.*

From here on out, every time the old feelings of condemnation and guilt pop up (and they will, because they have become a habit), go back to the Father and thank Him again for forgiving you and cleansing you, and tell Him, "I do not accept those false feelings of condemnation and guilt, but I do receive Your grace, and thank You for loving me, Abba!" It may take awhile for your feelings to catch up with the truth of your decision to receive God's grace, but that's OK. They will. Feelings follow beliefs and actions like a caboose follows the engine of a train.

The Lord bless you this day, _____, and I pray that you will hear the love in your Father's voice and see the love in His eyes as you receive His truth through this email!

“A Woman Has the Right to Decide What Lives or Not in Her Body”

Do you not think a woman has the right to decide what lives or does not in her body? You make it sound like women that have abortions are cold and do not care about what they are doing. But it simply isn’t like that. Is it better to bring a child into the world that isn’t wanted? I am 17 and I know if I get pregnant now it would ruin my life and the baby’s. I can simply not give that baby the life it deserves and that I want for it. Is it wrong to plan a stable emotional and financial future for your child?

I’m so glad you wrote.

I have been reading the “Answers to E-mails” section of your website. I agree with Sue B. I think that there is no room for small minded views in the 21st century. The church’s viewpoint belongs to and was made for a different time.

I think there is an important difference between small-mindedness, and an unpopular insistence on not departing from

what God has revealed to us in His word. "The church's viewpoint" is not timebound and irrelevant; it ultimately comes from God, who created reality and created us and thus has the right to make the rules and dictate the consequences of breaking those rules. One of His rules is, "Don't murder." We can't get away from the fact that abortion is taking the life of one's own child. There are deep and disturbing consequences to making that choice.

Do you not think a woman has the right to decide what lives or does not in her body?

Your phraseology needs to be more accurate: it's a "who," not a "what," that lives inside a mother's body. Once a baby has been conceived, it's a whole new human being inside another. I'm sure you want to empower women to control their bodies—but if you take this position, you are only for the empowerment of ADULT women. What about unborn baby girls? They don't have any power, which is why others have to protect them.

I'm all for women controlling their own bodies. . . to prevent conception in the first place. Once a woman gets pregnant, there are two lives involved and not just hers.

You make it sound like women that have abortions are cold and do not care about what they are doing. but it simply isn't like that.

I'm sorry, I don't know which article you read. A couple of us have written on abortion. My article [Abortion](#) explores the issue and facts of abortion, but the human, personal aspect is completely different. I know better than to think that women who have abortions are cold and uncaring. I know that abortion absolutely rips apart people's lives. I see for myself the aftereffects of abortion in the guilt and shame that last for years in women's lives, and it is my privilege to minister the truth to them that God wants to forgive and cleanse them of

their sin.

It's one thing to talk about abortion as a way to undo a mistake. . . but it's so important to never lose sight of the fact that it's killing another human being. That is a huge, serious choice to make. (I notice you didn't mention this.)

Is it better to bring a child into the world that isn't wanted?

Wanted by whom? There are far more would-be adoptive parents than there are available babies. Furthermore, no baby can be conceived without God calling them into existence; HE wants every single child! If the only one who matters is the pregnant woman, then her innocent baby is nothing more than a commodity on the level of the shoes she tried on but doesn't want to buy.

I am 17 and I know if I get pregnant now it would ruin my life and the baby's. I can simply not give that baby the life it deserves and that I want for it.

I'm so glad you see what an unwise thing it would be to get pregnant! Which is why abstaining from sex is the wisest, most mature choice for a number of reasons. And this is also why, if a baby is conceived anyway, giving him or her up for adoption—as excruciatingly painful as it is—is a way to give the baby the life s/he deserves.

Is it wrong to plan a stable emotional and financial future for your child

No! It's loving, and kind, and mature. That's why it's important to wait to have a baby until one is married and able to welcome him or her into a loving family.

Dear _____, precious child of God, beloved daughter of the King—

I am so very very VERY glad you wrote! I hurt with you. . . in fact, there are tears in my eyes as I write this to you—my heart hurts for you and for the burden you have been carrying all these years.

Let's get to the bottom line first: In Jesus' name, YOU HAVE ALREADY BEEN FORGIVEN!!! Because you have trusted Christ, the first time you confessed your sin of abortion and asked for God's forgiveness, He gave it to you. In fact, He POURED His forgiveness out on you like an anointing of oil. Listen to 1 John 1:9:

If we confess our sins, He is faithful and just to forgive us our sins and to cleanse us from all unrighteousness.

You confessed your sin, and because He is faithful and He is just (meaning, Jesus already paid for your sin at the cross), God the Father not only forgave you of your sin, He cleansed you from the stain of your guilt. Your feelings of being unforgiven and dirty and shame-filled have been lying to you, because the truth is, you are forgiven and clean and accepted in the Beloved (Eph. 1:6 KJV)

I want to challenge you to do something that will help you really GET this truth. Three times a day (at least), say out loud, "Thank You, Lord for forgiving me because Jesus died for me. I receive Your forgiveness and I receive Your cleansing. Thank You for making me clean and pure again." It really helps to say it out loud so that your spirit hears those words of truth come out of your mouth. This is the way of faith, the way we receive God's blessings by faith even before we feel them.

You have some work to do to get to the point where you can feel unashamed and pure again—but that's not a matter of

EARNING those things, but of changing your thinking so that you can embrace the reality that is yours to live out. Is there an Abortion Restoration or Recovery ministry near you? Ask the Lord to show you if there is; I don't know of any network of programs to check with, but I can point you to an excellent workbook you can do on your own. This is the book that is used at our church for the Abortion Restoration class that healed, post-abortal women offer a couple of times a year.

Also, there are a couple of websites where you can do some reading that will be very encouraging to you as you work your way through the necessary grieving of the loss of your baby (who is in heaven, and you will see him or her again some day!), and the necessary forgiving of those involved: yourself, the boy who got you pregnant, your parents, the Planned Parenthood people, and anyone else who played a part in the trauma to your soul.

I also suggest you listen to a lot of praise and worship music so that you focus on the Lord and let Him minister His love to you. As you do that, there's one prayer I would strongly suggest you pray, regularly: "Lord, show me how much You love me." He LOVES to answer that prayer!

You have not gone further than God's grace can reach, and you have done nothing that He cannot turn into good, for His glory and for your benefit. God wants to soak His grace down into the very bottom of your soul. Jesus' blood has covered and cleansed your sin, and you are clean and forgiven because He loves you so much He paid the ultimate price to prove it to

you.

I'm glad you told me your story, because with every telling, you release more of the shame and the guilt, and you take another step toward healing. Who knows. . . some day you may find yourself telling your story to young girls BEFORE they make the same mistake you did, and you will watch God redeem your pain to change lives to His glory!
